## **Increase in Annual NARF Subscription from January 2021 New Payment Mandate for Deduction from Pension**

I am writing to advise you that with effect from the 1st January 2021, it is intended to increase the annual subscription that you currently pay to NARF via your pension from a total of £9.00 to £12.00.

Although this increase may appear to be high, this the first increase to have been applied for approximately 15 years. As I am sure you will appreciate during this time the Associations costs both at National and Branch have risen year on year. Therefore, to ensure that expenditure does not exceed income it has become necessary to increase the subscriptions accordingly.
